PLLC Focus and Campaigns

- At the 2022 Reno Convention, the PLLC led the successful campaign to abolish the LP Abortion Plank (Plank 1.5) which rejected the protection in law of pre-born human life until the time of birth. The PLLC exists to ensure that the LP never returns to a pro-abortion position, but rather to move it in a more pro-life direction.
- In addition to advocating for the Life and Liberty of the pre-born within the LP, we partner with Crisis Pregnancy Centers, Adoption Centers and others to advance care and protection of mothers and their pre-born children.

PLLC Platform Provisions

- *Personhood.* We believe the beginning of life should be determined by science, and not purely on an arbitrary basis as it currently is, and that a human being is a person who is entitled to the right to life as soon as life has been established.
- *Non-Aggression Principle (NAP).* We believe that initiating the use of force to kill a person at any stage is not only inherently immoral, but also a clear violation of the NAP. This would put any other view besides the pro-life view at odds with the non-aggression philosophy of the Libertarian Party.
- *State’s Rights.* We believe that each State has the right to decide what level of protection for preborn persons they wish to provide. However, we

would urge every State to protect life from the time of conception.

- *Government Involvement.* We realize that abortion will not truly end in this country with the passing of laws. Prohibition has never ended anything. This does not mean that we should advocate for inaction by government. The Libertarian Party platform supports the prohibition of the initiation of physical force against others. Since abortion is the initiation of force, we believe government has a duty to secure the rights of preborn people.
